LEGEND INTERNATIONAL HOLDINGS ANNOUNCES THAT MACRO- DIAMONDS AND KIMBERLITIC CHROMITES HAVE BEEN RECOVERED IN A STREAM SAMPLE AT THE ABNER RANGE PROJECT IN THE NORTHERN TERRITORY OF AUSTRALIA

Melbourne Australia – April 11, 2007 - Legend International Holdings, Inc (OTC-BB: LGDI.OB) (a Delaware Corporation), a diamond exploration corporation with landholdings in the Northern Territory of Australia, announces a stream gravel sample (ABR024) collected in March 2007 within the Company's tenement EL23514 has returned 2 macro-diamonds (-1+0.8mm) and 9 chromites (-0.8+0.3mm). Three of the chromites have mineral chemistries suggesting origin from a diamondiferous kimberlite. The presence of multiple chromites and diamonds is indicative of a proximal, diamondiferous kimberlite source. The sample is less than 7 kilometers to the south west of the recently discovered Abner Range diamondiferous kimberlite owned by Gravity Diamonds Limited. The sample is located in a drainage headwater on the Abner Plateau, and the catchment for the positive sample is completely contained within EL23514. The upstream region is suitable for loam grid sampling and further stream sampling, which will commence immediately. Lineament trends similar to the emplacement trend of the Abner Range kimberlite (north north east) exist with the prospective area. Numerous priority geophysical targets exist upstream within 1kilometre of the sample site. All geophysical anomalies, structural targets and chromite anomalies generated from the current loam sampling will be drill tested in the coming months.


